

# VALUES VOTER GUIDE PRIMARY ELECTION 2016

Yes, there are other political races besides the President of the United States. On June 14th the State of Nevada will hold its primary election, with early voting beginning May 28th.

Nevada Concerned Citizens has sent out question-naires to candidates vying for the Democrat and Republican nominations, as well as a number of non-partisan races. All federal, statewide, State Senate, and State Assembly offices have been included, as well as University Regent and State Board of Education. Judicial offices include the Nevada Supreme, Appellate and District Courts. We also cover Clark County offices such as the County Commission, School Board, and Justice of the Peace. Answers to our questions by the candidates provide important information for your decision on election day. We believe that we are asking questions that are important to you and not provided by any other source. It's an opportunity to compare your values to those of the candidate.

We have been asked many times whether or not you should vote for a candidate who chooses not to respond to our questionnaire. Unfortunately, due to the nature of our questions, leaders in both parties as well as campaign consultants sometimes recommend against responding. I have an inclination to not vote for a non-responsive candidate. However, there are always unanticipated circumstances that give me pause.

Of course it is up to you to decide based on information you have received from all sources about a candidate.

President Reagan once said, "Freedom is never more than one generation away from extinction. We didn't pass it to

our children in the bloodstream. It must be fought for, protected, and handed on for them to do the same."

## And fight we must!

Just this week Obama's Justice Department threatened to cut off education funding because of a state's new law prohibiting men and boys from using women's and girl's restrooms and locker rooms.

Here is a statement from a group of parents after their girl's school succumbed to Obama's threats and a male is now using the girl's locker room.

"Every day these girls go to school, they experience embarrassment, humiliation, anxiety, fear, apprehension, stress, degradation and loss of dignity because they will have to use the locker room and restroom with a biological male."

# NCC VALUES VOTER GUIDE

Questions 1-11 are common to all candidates. (Judicial questions are separate)

- 1. Do you support or oppose a "path to citizenship" for illegal immigrants? (i.e., pass a background check; register; pay a penalty fee; apply for a temporary non-immigrant visa, etc
- 2. Do you support or oppose legalization of the recreational use of marijuana?
- 3. Would you support or oppose legislation to protect the right to life of every person from conception to natural death? Any exceptions?\_\_\_\_\_
- 4. Do you support or oppose allowing a "transgendered" male who identifies as female to have access to women's sports teams, locker rooms and restrooms?
- 5. Would you support or oppose a Federal Constitutional Marriage Amendment defining marriage as being between one man and one woman, reinstituting Nevada's marriage laws?
- 6. Do you support or oppose the concept of "defined benefits" as a basis for public employee retirement plans, in contrast to investment returns as a basis for benefits?
- 7. Do you support or oppose "Common Core"?
- 8. Would you support or oppose the elimination of the Federal Department of Education, fully returning education decisions and tax dollars to the states?
- 9. Would you support or oppose legislation to ban prostitution in Nevada (including localities)?
- 10. Do you support or oppose Religious Liberties/Conscience Protections for all citizens (health care workers, small business owners, etc) as opposed to protections only for religious organizations and their employees?
- 11. Did you support or oppose Nevada's Commerce Tax (Gross Receipts Tax) passed in the 2015 legislative session?
